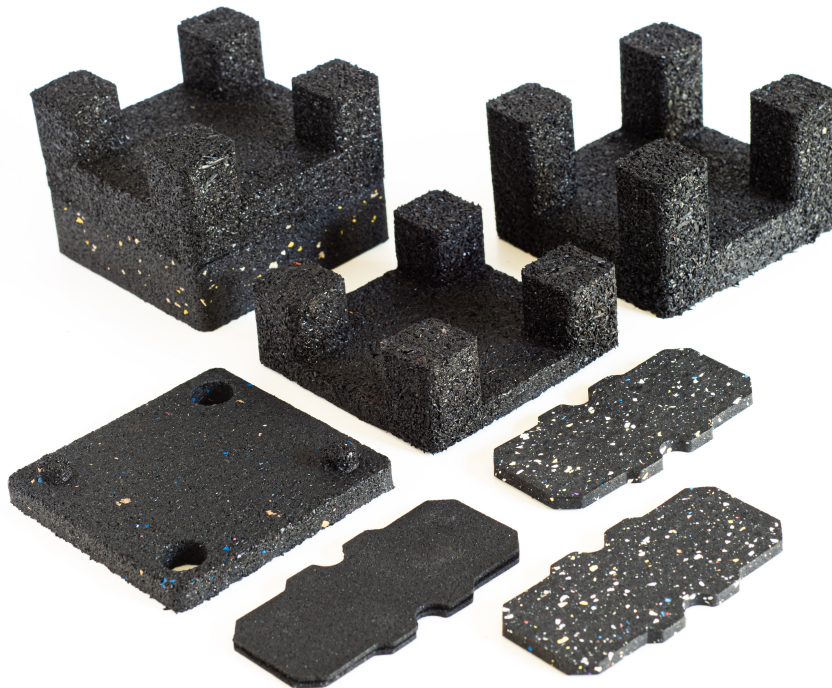

Section 3: Composition/ Information on Ingredients	
The cradles and packers are manufactured from Recycled tyre shred and granules from car / truck origins. 92% of the cradle mass is rubber. The rubber shred / granules are sourced from re-treading companies. This is graded into 1-4mm rubber shred / granules size. The rubber shred / granules are bound with a flexible polyurethane (8%) binder. The binder is classified as non-hazardous and is chemically inert.
